FORM OF AGREEMENT

This Contract is made this day of 16th day of November, 2021

BETWEEN

SONGEA URBAN WATER SUPPLY AND SANITATION AUTHORITY, P. O. Box 363, SONGEA to be known/ referred to as "the EMPLOYER" on one part;

AND

KAMBELA LIMITED, P.O. Box 648, SONGEA, Tanzania to be known/ referred to as "the CONTRACTOR" on the other part;

Whereas the Employer is desirous that certain works should be carried out by the Contractor, viz: **Construction of Water Supply Project at Pambazuko in Songea Municipal** and has by the letter of Acceptance Ref. No. SOUWASA/REP.37/VOL.V/105 dated 15/11/2021 accepted a Tender by the Contractor for execution, and completion of such Works and remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz: -
 - a) Form of Agreement;
 - b) Priced Bill of Quantities
 - c) Tender Submission Form.
 - d) Letter of Acceptance;
 - e) General Conditions of Contract.
 - f) Special Conditions of Contract.
 - g) Specifications.
 - h) Minutes of contract negotiation
3. In consideration of the payments Tanzania Shillings 546,104,822.18 (Tshs. Five Hundred Forty Six Million One Hundred Four Thousand Eight Hundred Twenty Two Cents Eighteen Only) VAT exclusive to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the works in conformity, in all respects, with the provisions of the Contract.

4. All the aforesaid documents are hereinafter referred to as 'the Contract' and shall be taken as complementary and mutually explanatory of one another but in case of ambiguities or discrepancies shall take precedence in the order set out above.
5. The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the works, the Contract Price stated above at the times and in the manner prescribed by the Contract.


