FORM OF CONTRACT AGREEMENT

THIS AGREEMENT made the 6 day of October 2021 between **Sumbawanga Urban Water Supply and Sanitation Authority (SUWASA) of P.O. Box 192, Sumbawanga-Rukwa** (hereafter called "the Procuring Entity") of the one part and **M/S Kahama Oil Mills Limited of P.O. Box 16541 Kahama-Shinyanga, Tanzania** (hereafter called "the Supplier") of the other part.

WHEREAS the Procuring Entity is desirous that the Supplier execute **The Supply of HDPE Pipes for Water Network Extension** immediately after Contract Signing at SUWASA Offices in Sumbawanga Municipality, Rukwa region, **Tender No. AE/045/2021/2022/G/03** (hereinafter called "the Goods and Service") and the Procuring Entity has accepted the Bid by the Supplier for the Contract Price of the **TZS 162,854,160.00 (One Hundred Sixty Two Million Eight Hundred Fifty Four Thousand One Hundred Sixty Only) VAT Inclusive**, for the execution and completion of such Supply of Goods and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract referred to.

(g) The Procuring Entity's Letter of Acceptance and

-Performance Security

-Test Certificate from TBS, or any Authorized Institution

3. In consideration of the payments to be made by the Procuring Entity to the Supplier as hereafter mentioned, the Supplier hereby covenants with the Procuring Entity to provide the goods and services and to remedy defects therein in conformity in all respect with the provisions of the Contract

4. The Procuring Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and Services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the times and in the manner prescribed by the contract.
