

Form of Contract Agreement

This Agreement, is made this ²²..... day of ^{Nov}....., 2021 between **Morogoro Urban Water Supply and Sanitation Authority, P.O. Box 5476 - Morogoro (hereinafter called "the Employer")** and **M/S Serengeti Ltd, P.O. Box 72374 - Dar es Salaam (hereinafter called "the Contractor")** of the other part.

Whereas the Employer is desirous that the Contractor execute the works of **installation of submersible water pump, construction of raising main and extension of distribution network at Kasanga Township [Tender No. AE/038/2021-2022/W/04]** (hereinafter called "the Works") and the Employer has accepted the Tender by the Contractor for the execution and completion of such works and the remedying of any defects therein in the Sum of **Tanzania Shillings Six Hundred Sixteen Million Two Hundred Thirty-Seven Thousand One Hundred Fourteen (TZS.616,237,114)**. (Hereinafter called "Contract Price")

The contract Sum amounting to **Five Hundred Ninety Million Nine Hundred Thirteen Thousand Two Hundred Fifty and Twenty Cents, VAT Exclusive (TZS. 590,913,250.20 VAT Exclusive)** will be paid by Ministry of Water and

The remaining contract Sum amounting to **Twenty-Five Million Three Hundred Twenty-Three Thousand Eight Hundred Sixty-Four, VAT Exclusive (TZS. 25,323,864) VAT Exclusive** will be paid by **Morogoro Urban Water Supply and Sanitation Authority (MORUWASA)**.

Now this Agreement witnessed as follows: -

1. In this Agreement, words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract hereinafter referred to, and they shall be deemed to form and be read and construed as per of this Agreement.
2. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy any defects therein in conformity in all respects with the provisions of the Contract.
3. The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein the Contract Price or such other Sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
