

FORM OF AGREEMENT

This Agreement, made the 17th day of NOVEMBER, 2021 between the **Managing Director, Handeni Trunk Main Water Supply and Sanitation Authority** of P.O.Box 80, Korogwe hereinafter called "the Employer") on the one part and , **Saxon Building Contractor** of P.O. Box 22347, Dar Es Salaam (hereinafter called "the Contractor") on the other part.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

3. All the aforesaid documents are hereinafter referred to as 'the Contract' and shall be taken as complementary and mutually explanatory of one another but in case of ambiguities or discrepancies shall take precedence in the order set out above.
4. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the works in conformity, in all respects, with the provisions of the Contract.
5. The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the works, the sum of **Tanzanian Shillings: Six**
