FORM OF CONTRACT

LTD** of P.O. BOX 721, Sumbawanga (hereinafter called "the Supplier") of the other party, but will be effected soon after the disbursement of funds from ministry of education and technology.

WHEREAS the Purchaser invited Tenders No. **CFDC/2021-2022/UVIKO-19/FA/6**, for the sum of **TZS 42,521,400.00** VAT Inclusive (hereinafter called "the Contract Price").

NOW THIS CONTRACT WITNESSETH AS FOLLOWS:

The Purchaser hereby covenants to pay the Suppliers in consideration of the provision of the **Supply of Plumbing Materials** and the remedying of the defects therein, the Contract Price of **TZS 42,521,400.00** Inclusive or such sum as may become payable under the provisions of the Contract at the terms and in the manner prescribed by the Contract.
