**FORM OF CONTRACT**

THIS CONTRACT is made this 20<sup>TH</sup> day of November, 2021 between **Chala FDC** of P.O.Box 503 Sumbawanga, Rukwa (hereinafter called "the Purchaser") of the one party and **M/S. WHEREAS the Purchaser invited Tenders **No. CFDC/2021-2022/UVIKO-19/FA/7**, for the sum of **TZS 73,016,300.00** VAT Inclusive (hereinafter called "the Contract Price").

**NOW THIS CONTRACT WITNESSETH AS FOLLOWS:**

3. In consideration of the payments to be made by the Purchaser to the Suppliers as hereinafter mentioned, the Supplier hereby covenants with the Purchaser for the **Supply of Electrical Materials** and to remedy defects therein in conformity in all respect with provisions of the Contract.

The Purchaser hereby covenants to pay the Suppliers in consideration of the provision of the **Supply of Electrical Materials** and the remedying of the defects therein, the Contract Price of **TZS 73,016,300.00** Inclusive or such sum as may become payable under the provisions of the Contract at the terms and in the manner prescribed by the Contract.
