- (b) The Contractor is a Company registered under the Laws of Tanzania which is responsible for Construction of Civil works and register CRB Class(V
- (c) The Employer invited Tender for Extension of Meserani juu- Meserani Bwawani Monduli District Tender No:AE-102/2021-2022/ARS/C/W/02 under the terms and conditions set forth in this Contract;
- (d) The Contractor having represented to the Employer that it has the required professional skills, expertise and technical resources, the Employer through the Letter of Notification of Award of Tender with Ref. Ref. No. DA.130/258/01/216 Dated 19th December, 2021 awarded a Tender to the Contractor at the contract sum of **Three Hundred Million Only (300,000,000) VAT Exclusive** (hereinafter referred to as "**the Contract Price"**).

## **NOW THEREFORE** the Parties hereby agree as follows:

1. In this contract, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

The following documents shall be deemed to form and be read and construed as an integral part to this contract, and shall be taken as complementary and mutually explanatory of one another but in the event of ambiguities, inconsistency or discrepancies within the Contract, the documents shall take precedence/prevail in the order set out below:

- 3. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to provide the said contractor and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 4. The Employer hereby covenants to pay the Contractor in consideration of the execution and completion for for Extension of Meserani juu- Meserani Bwawani Monduli District Tender No :AE-102/2021-2022/ARS/C/W/02 the sum of Three Hundred Million Only (300,000,000) VAT Exclusive, at the times and in the manner prescribed in this Contract.
- 5. The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract as follow
  - a) 15% Advance Payment shall be paid to the Supplier within twenty Eighty (28) days after the date of Signing of the Contract the Contract price shall be paid in **Tanzanian Shillings** as stipulated under Clause 18 of the SCC.
- 6. The contract shall be executed for the period of **three month (3)** which shall immediately commence from the date of signing this Contract.
