In consideration of the payments to be made by the PE to the Supplier in the sum of Tsh.89,623,460.00 in words Eight nine million six hundred twenty three thousand four hundred sixty only VAT Exclusive. The Supplier hereby covenants with the PE to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
