

Form of Contract Agreement

This Agreement, is made this 22 day of NOV, 2021 between **Morogoro Urban Water Supply and Sanitation Authority, P.O. Box 5476 - Morogoro** (hereinafter called "the Employer") and **Ms. Oldvai Decorators and General Suppliers, P.O. Box 7868 - Dar es Salaam** (hereinafter called "the Contractor") of the other part.

Whereas the Employer is desirous that the Contractor execute the works of **Construction of 90m³ Water Storage Tank and Distribution Network at Msimba-Mikumi [Tender No. AE/038/2021-2022/W/ 09/Lot 01]** (hereinafter called "the Works") and the Employer has accepted the Tender by the Contractor for the execution and completion of such works and the remedying of any defects therein in the sum of **Tanzania Shillings Three Hundred Thirteen Million Two Hundred Sixty Thousand, VAT Exclusive (TZS.313,260,000 VAT Exclusive)** (hereinafter called "Contract Price").

Now this Agreement witnessed as follows: -

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to, and they shall be deemed to form and be read and construed as per of this Agreement.
2. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy any defects therein in conformity in all respects with the provisions of the Contract.
3. The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
