FORM OF CONTRACT AGREEMENT

WHEREAS the Procuring Entity is desirous that the Supplier execute **The Supply of Water Meters** immediately after Contract Signing at SUWASA Offices in Sumbawanga Municipality, Rukwa region, **Tender No.** AE/045/2021/2022/G/05 (hereinafter called "the Goods and Service") and the Procuring Entity has accepted the Bid by the Supplier for the Contract Price of the TZS 254, 298,064.10 (Two Hundred Fifty Four Million Two Hundred Ninety Eight Thousand Sixty Four and Ten cents Only) VAT Inclusive, for the execution and completion of such Supply of Goods and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract referred to.

 - (e) The General Conditions of contract;
 - (f) The Special Conditions of Contract;
 - (g) The Procuring Entity's Letter of Acceptance and
 - (h) Other documents:
 - -Performance Security
- 3. In consideration of the payments to be made by the Procuring Entity to the Supplier as hereafter mentioned, the Supplier hereby covenants with the Procuring Entity to provide the goods and services and to remedy defects therein in conformity in all respect with the provisions of the Contract

4. The Procuring Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and Services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the times and in the manner prescribed by the contract.
