## FORM OF CONTRACT

This Agreement is made this 23 day of MAY, 2022 between SINGIDA URBAN WATER SUPPLY AND SANITATION AUTHORITY, P.O Box 174, Singida (hereinafter called "the Client") and

M/s N AND S GROUND WATER TANZANIA LIMITED, P.OBOX 1235,Dodoma (hereinafter called "the Contractor") of the other part.

Whereas the Client is desirous that the Contractor carry out "*HYDROGEOLOGICAL AND GEOPHYSICAL SURVEYING, DRILLING, AND PUMPING TEST OF A PRODUCTIVE BOREHOLE AT MWAKOKOKO WELLFIELD THROUGH COVID 19 FUND*" hereinafter called "the Works" and the Client has accepted the Tender by the Contractor for the execution and completion of such works and the remedying of any defects therein in the sum of *Tsh 148,940,000/= Vat exclusive* (hereinafter called "Contract Price").

Now this Agreement witnesses as follows:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to, and they shall be deemed to form and be read and construed as part of this Agreement.
2. In consideration of the payments to be made by the Client to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Client to execute and complete the Works and remedy any defects therein in conformity in all respect with the provisions of the Contract.
3. The Client has received fund from the United Republic of Tanzania through Ministry of water (hereinafter called the Government) towards the cost of the services and intends to apply the portion of the proceeds of this fund to eligible payments under this contract, it being understood (i) that payments will be made only at the request of the Client and upon approval by the Ministry of water [or Government], (ii) that such payments will be subject in all respect, to the terms and conditions of the agreement providing for the fund and (iii) that no party other than the Client shall derive any rights from the agreement providing for the fund or have any claim to the fund proceeds;
4. The Client hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.

5. The Contractor having presented to the Client that it has the required professional skills, personnel and technical resources has agreed to perform the works on the terms and conditions set forth in this contract.
  
6. The documents forming the Contract shall be interpreted in the following order of priority:
  - i. Letter of Acceptance
  - ii. Special Conditions of Contract,
  - iii. Conditions of Contract,
  - iv. Specifications,
  - v. Special Power of Attorney
  - vi. Bill of quantities
  
7. The mutual rights and obligations of the Client and the Contractor shall be as set forth in the Contract, in particular:
  - (a) The Contractor shall perform the works in accordance with the provision of the contract, and
  - (b) The Client shall make payment to the Contractor in accordance with the provision of this contract.
