M/S. VIBE INTERNATIONAL COMPANY LIMITED having its principal place of business at P.O. Box 71992, Dar es Salaam (hereinafter called "the Contractor") of WHEREAS

The Employer is desirous that the Contractor execute the Tender No. NO AE-102/2021-

2022/MOR/W/25 for Construction of Sagamaganga Water Supply Project in Kilombero District in Morogoro Region (hereinafter called "the Works") and the Employer has accepted the Bid by the Contractor for the execution and completion of such works and the remedying of any defects therein in the sum of TZS 397,882,999.60 (Three hundred ninety seven million eight hundred eighty two thousand nine hundred ninety nine shillings and sixty cents) with VAT exclusive. [Hereinafter called "Contract Price"]. The contract period is 180 Calendar days. Now this Agreement witnesses as follows:

- In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy any defects therein in conformity in all respects with the provisions of the Contract.
