FORM OF AGREEMENT

This Agreement, made the^{7th} day of^{JANUARY}, 2021st
Between

The Rural Water Supply and Sanitation Agency (RUWASA), having its physical address **P.O.BOX 1140, Morogoro** (hereinafter called "the Employer") of one part
And

M/S. VIBE INTERNATIONAL COMPANY LIMITED having its principal place of business at **P.O. Box 71992, Dar es Salaam** (hereinafter called "the Contractor") of the other part.

WHEREAS

The Employer is desirous that the Contractor execute the Tender No. **NO AE-102/2021-2022/MOR/W/25 for Construction of Sagamaganga Water Supply Project in Kilombero District in Morogoro Region** (hereinafter called "the Works") and the Employer has accepted the Bid by the Contractor for the execution and completion of such works and the remedying of any defects therein in the sum of **TZS 397,882,999.60 (Three hundred ninety seven million eight hundred eighty two thousand nine hundred ninety nine shillings and sixty cents) with VAT exclusive.** [Hereinafter called "Contract Price"]. The contract period is **180 Calendar days.**
Now this Agreement witnesses as follows:


1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to, and they shall be deemed to form and be read and construed as part of this Agreement.
2. The following documents shall be deemed to form and be read and construed as part of this agreement. This Agreement shall prevail over all other contract documents:

 - (b) The Letter of Acceptance
 - (c) The Contractor's Bid
 - (d) The Special Conditions of Contracts
 - (e) The General Conditions of Contracts

 - (g) The Drawings
 - (h) The Bill of Quantities
 - (i) The Performance Security & Advance Payment Security Forms
 - (j) The works programmes
 - (k) The Registered power of Attorney and
 - (l) The Minutes of Negotiation
3. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy any defects therein in conformity in all respects with the provisions of the Contract.

4. The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein the Contract Price **of TZS 397,882,999.60 (Three hundred ninety seven million eight hundred eighty two thousand nine hundred ninety nine shillings and sixty cents) with VAT exclusive** [Hereinafter called "Contract Price"]. or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
5. This contract commences on 17th day of JANUARY in the year 2022 and shall automatically end on 16th Of JULY In the year 2022, unless there is express permission for time extension from the employer.
