Form of Contract

Kahama Urban Water Supply and Sanitation Authority (KUWASA) of P.O.BOX 102 Kahama (hereinafter "the Purchaser"), of the one part, and **M/S TRANSOCEAN SUPPLIES LIMITED** of P.O.BOX 10216 Dar es salaam, (hereinafter "the Supplier"), of the other part:

WHEREAS the **Kahama Urban Water Supply and Sanitation Authority (KUWASA)** invited Tenders for certain goods and ancillary services, viz., *galvanized steel pipes and fittings* and has accepted a Tender by the Supplier for the supply of those goods and services in the sum of **Tanzania shillings Two Hundred Twenty Two Million Three Hundred Thousand Two Hundred Only (222,300,200.00) VAT inclusive** (Hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, In the event of any ambiguity or conflict between the Contract Documents listed below, the order of precedence shall be the order in which the Contract Documents are listed below:-

 - c) Letter of acceptance
 - d) Schedule of requirements and prices
 - e) General condition of contract
 - f) Special condition of contract
 - g) Technical specifications
 - h) Power of attorney
3. In consideration of the payments to be made by **Kahama Urban Water Supply and Sanitation Authority (KUWASA)** to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the purchaser to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract

4. The purchaser hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the times and in the manner prescribed by the contract.
