FORM OF AGREEMENT

The Rural Water Supply and Sanitation Agency (RUWASA), having its physical address P.O.BOX 1140, Morogoro(hereinafter called "the Employer") of one part

And

M/S. JEMASON INVESTMENT CO. LTD having its principal place of business at P.O. Box 4277, Dar es Salaam (hereinafter called "the Contractor") of the other part.

WHEREAS

The Employer is desirous that the Contractor execute the Tender No. NO AE-102/2021-2022/HQ-C/W/35 for Construction of Ikule Water Supply Project in Kilombero District - Morogoro Region (hereinafter called "the Works") and the Employer has accepted the Bid by the Contractor for the execution and completion of such works and the remedying of any defects therein in the sum of TZS 512,556,660.00 (Five hundred twelve million five hundred fifty six thousand six hundred sixty only) with VAT exclusive. [Hereinafter called "Contract Price"]. The contract period is 180 Calendar days.
