Form of Agreement

This AGREEMENT (hereinafter called the "Contract") is made this 05 day of May 2022 between Wanging'ombe Water Supply and Sanitation Authority (hereinafter called the "Employer") of the one part, and Tanzania Electric Supply Company Limited (WANGING'OMBE) (hereinafter called the "Service Provider") of the other part.

"Wanging'ombe Water Supply and Sanitation Authority (hereinafter called the "Employer") and, on the other hand, *Tanzania Electric Supply Company Limited (WANGING'OMBE)* (hereinafter called the "Service Provider") each of which shall be jointly and severally liable to the Employer for all the Service Providers' obligations under this Contract.

WHEREAS

- (a) the Employer has requested the Service Provider to provide certain Services as defined in the Special Conditions of Contract attached to this Contract (hereinafter called the "Services");
- (b) the Service Provider, having represented to the Employer that they have the required professional skills, personnel and technical resources, have agreed to provide the Services on the terms and conditions set forth in this Contract at a contract price of 50,465,522.57 in Tanzania shillings (All service supplied to the project shall be exempted from VAT in accordance with existing laws)
- (c) the Employer has committed funds towards eligible payments under this Contract, it being understood that such payments will be subject, in all respects, to the terms and conditions of the Contract providing for the funds and that no party other than the Employer shall derive any rights from the Contract providing for the funds or have any claim to the funds proceeds;

NOW THEREFORE, the parties hereto hereby agree as follows:

 - a) Form of Agreement;
 - b) Letter of Acceptance;
 - c) The Special Conditions of Contract;
 - d) The General Conditions of Contract;
 - e) Quotation.
- 2. The mutual rights and obligations of the Employer and the Service Provider shall be as set forth in the Contract, in particular:
 - The Service Provider shall carry out the Services in accordance with the provisions of the Contract; and
 - b) The Employer shall make payments to the Service Provider in accordance with the provisions of the Contract.
