FORM OF AGREEMENT

RUNNASA REGIONAL MANAGER & MOROGORO

Between

The Rural Water Supply and Sanitation Agency (RUWASA), having its physical address P.O.BOX 1140, Morogoro (hereinafter called "the Employer") of one part

And

M/S. MACEA CONSTRUCTION LIMITED having its principal place of business at P.O. Box 425 Morogoro, (hereinafter called "the Contractor") of the other part. WHEREAS

The Employer is desirous that the Contractor execute the Tender No. AE-102/2021-2022/HQ-C/W/38 for Improvement of water supply services at Kauzeni area Project . (hereinafter called "the Works") and the Employer has accepted the Bid by the Contractor for the execution and completion of such works and the remedying of any defects therein in the sum of TZS 592,192,422.94 (Five hundred ninety two million one hundred ninety two thousand four hundred twenty two and Ninety four Cents) with VAT exclusive. [Hereinafter called "Contract Price"]. The contract period is 180 Calendar days.

Now this Agreement witnesses as follows:

- In this Agreement, words and expressions shall have the same meanings as are 1. respectively assigned to them in the Conditions of Contract hereinafter referred to, and they shall be deemed to form and be read and construed as part of this Aareement.
- The following documents shall be deemed to form and be read and construed as 2. part of this agreement. This Agreement shall prevail over all other contract documents:

 - (b) The Letter of Acceptance
 - (c) The Contractor's Bid
 - (d) The Special Conditions of Contracts
 - (e) The General Conditions of Contracts
 - (f) The Specifications
 - (g) The Drawings
 - (h) The Bill of Quantities
 - (i) The Performance Security & Advance Payment Security Forms
 - (j) The works programmes
 - (k) The Registered power of Attorney and
 - (I) The Minutes of Negotiation
- In consideration of the payments to be made by the Employer to the Contractor 3. as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy any defects therein in conformity in all respects with the provisions of the Contract.

- 4. The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein the Contract Price of TZS 592,192,422.94 (Five hundred ninety two million one hundred ninety two thousand four hundred twenty two and Ninety four Cents) with VAT exclusive. [Hereinafter called "Contract Price"]. or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
