# AGREEMENT FOR HIRE OF EQUIPMENT

CONTRACT NO. TMS/TEP-TN/2021/2022

AGREEMENT made the 04 day of MARCH, 2022 between  
TEMESA EQUIPMENT POOL (TEP) of P.O Box .....  
(hereinafter referred to as "the Owner") of the one part:

VETA-VEHONDA ..... And 2208-Mopolano ..... Hereinafter  
"hirer" of the other part:  
It is AGREED as follows:

1. The Owner lets and the Hirer hires equipment(s) in the schedule here to (hereinafter referred to as "the Equipment(s)") from the dates specified in the schedule until the hiring is determined as hereinafter provided. The Hirer will provide fuel for the Equipments(s).
2. The Owner shall provide wages for the driver(s) and/or operator(s) of the Equipment(s). However, the Hirer shall pay any overtime and/or night Allowance to the driver(s) and/or operator(s).
3. Prior to taking the Equipment(s) the Hirer shall pay the owner a deposit of Tshs. 5,800,000 PER V ..... Date .....
4. All hire charges (hereinafter referred to as "the charges") shall; be paid within thirty days (30) after the end of the hiring or upon a date of issue of the invoice(s).
5. Late payment of the charges shall attract an interest of thirty percent 30% per annum charged from the Date the payment became due.
6. The Hirer shall pay Equipment(s) transportation costs to and from the work site.
7. The Hirer shall ensure safety and security of the Equipment(s) during the period of hire. Should the Equipment(s) or parts hereof be stolen while under the possession of the Hirer he shall be liable for the immediate restoration?
8. The Owner shall provide equipment work tickets to be filled by the driver And/or operator and signed by the Hirer. If the Hirer for whatever reason cannot sign the work tickets or cannot be available to sign the work tickets, he shall appoint by special powers of attorney another person ready available on site to sign on his/her behalf. The said work ticket shall form part of this Agreement and shall be read together in seriatim.
9. The Equipment (s) so hired shall be driven and or operated by the driver(s) and/or operator(s) duly Appointed by the Owner.
10. The Hirer shall report to the Owner any breakdown of the Equipment(s) for the purpose of recording the idle time that will not be charged to the Hirer.
11. The Owner will not be liable for any damage consequential or not caused by Breakdown of equipments so hired to the Hirer.
12. In case of failure to pay the charges on the part of the Hirer, the Owner shall have recourse to the amount due to the Hirer from any contract of works signed by the Hirer.

13. The Hirer hereby consents to the deductions of his/hire/its payment certificate Under any contract of works to pay for any outstanding charges.
14. The Hirer during continuation of the hiring shall not sale or offers for sale, mortgage, pledge, underlet, lend or otherwise deal with or part with possession of the Equipment(s) or any part thereof, in anyway whatsoever.\
15. The Hirer shall not interfere with or adjust the Equipment(s) in any way but upon any fault occurring shall immediately inform the Owner who shall without delay repair or replace the Equipment(s) provided that the Hirer shall keep the Owner indemnified against all defects and damage to the Equipment(s) caused by willful misuse of it.
16. The Hirer may determine the hiring at any time by giving a reasonable notice in writing.
17. The Hirer declares not to have any debts relating to hiring of any Equipment(s) from any other TEMESA Equipment Pool or he has equipment hire contracts with TEMESA Equipment Pool ..... worth Tshs.....
- 17.1 The Owner may determine the hiring in the following circumstances;
  - 17.2 At any time by giving reasonable notice in writing to the Hirer.
  - 17.3 The Hirer making default the punctual payment of the charges
  - 17.4 Upon receiving an order of bankruptcy against the Hirer.
  - 17.5 Upon Hirer going into liquidation voluntary or involuntary
  - 17.6 Upon breach of any of the terms herein by the Hirer.
18. In any such case the owner may retake possession of the Equipment(s) and for that purpose may enter upon the premise(s) where the Equipments is/are located and such determination by the owner shall not affect the right to recover any amount due to at the time of such determination or to recover damages for breach under this Agreement.
19. The equipment hired is to be used for execution of contract as shown bellow.
20. Upon any delay of the work for non-official reason, the hirer shall pay idle time equal to half Of hiring charges per day.
