FORM OF CONTRACT

THIS CONTRACT is made this 20TH day of November, 2021 between **Chala FDC** of P.O.Box 503 Sumbawanga, Rukwa (hereinafter called "the Purchaser") of the one party and **M/S. WHEREAS the Purchaser invited Tenders **No. CFDC/2021-2022/UVIKO-19/FA/5**, for the sum of **TZS 297,200,000.00** VAT Inclusive (hereinafter called "the Contract Price").

NOW THIS CONTRACT WITNESSETH AS FOLLOWS:

The Purchaser hereby covenants to pay the Suppliers in consideration of the provision of the **Supply of Aluminium & Hardware Materials** and the remedying of the defects therein, the Contract Price of **TZS 297,200,000.00**VAT Inclusive or such sum as may become payable under the provisions of the Contract at the terms and in the manner prescribed by the Contract.
