

FORM OF AGREEMENT

This Agreement made the 26th day of November, 2021 between **DODOMA URBAN WATER SUPPLY AND SANITATION AUTHORITY (DUWASA)**, P.O Box 431, Dodoma (hereinafter called "Employer") of the one part and **TANZANIA ELECTRIC SUPPLY COMPANY LIMITED, P. O Box 453, Dodoma** (hereinafter called ("the Service Provider")) of the other part:



WHEREAS

- (a) the Employer has requested the service provider to provide Electrical services at **Ntyuka** as defined in the special conditions of the contract attached to this contract (hereinafter called "the Service")
- (b) the service provider, having represented to the employer that they have the required the professional skills, personnel and technical resources, have agreed to provide the services on terms and condition set forth in this contract at a contract price of **5,127,014.92** Tanzania shillings (**All services supplied to the project shall be exempted from VAT in accordance with existing laws**)
- (c) the employer has committed funds toward eligible payments under this contract, it being understood that such payments will be subject, in all respect, to the term and conditions of the contract providing for the funds and that no party other than the employer shall derive any rights from the contract providing for the funds or have any claim to the funds proceed;

NOW THEREFORE, the parties hereto hereby agree as follow:

2. The mutual right and obligation of the Employer and Service Provider shall be as set forth in the Contract, in particular:
 - a) The service provider shall carry out the service in accordance with the provisions of the contract; and
 - b) The Employer shall make payments to the Service Provider in the accordance with the provisions of the contract.
