AND

M/S PACIFIC DIAGNOSTICS LIMITED, a corporation incorporated under the laws of Tanzania and having its principal place of business at **P.O. BOX 34056, DAR ES SALAAM** (Hereinafter referred to as "The Supplier" which expression shall where the context so permit include its assignees and successors of title) of the one part.

WHEREAS, The Parties hereto are Parties to a **Contract for The Supply, Installation, Testing, Commissioning, Training and Maintenance of Radiology Equipment (CT Scan) for Singida RRH, Tabora RRH and Dodoma RRH** made on 14th day of March, 2022.

WHEREAS, the original contract entered by the parties on 14th day of March, 2022, had the duration period of 12 weeks starting from 14th March, 2022 ending 14th June, 2022.

AND WHEREAS, The parties under the Contract for the Supply, Installation, Testing, Commissioning Training and Maintenance of Radiology Equipment (CT Scan) for Singida Regional Referral Hospital, Tabora Regional Referral Hospital and Dodoma Regional Referral Hospital are desirous of reviewing the contract by reducing the value of contract as provided herein;

NOW THEREFORE the client and the supplier do hereby agree as follows:

1. *Reducing Price of **Tanzanian Shillings One Hundred Twenty Million Only (Tshs 120,000,000.00) VAT inclusive.***
2. *The contract sum has changed after price adjustment from the original contract amount of **Tanzanian Shillings Five Billion Five Hundred Fifty Million [Tshs 5,550,000,000.00] VAT exclusive** resulting to **Tanzanian Shillings Five Billion Four Hundred Thirty Million only (TZS. 5,430,000,000.00) VAT Exclusive***
3. The contract terms and conditions shall remain the same as it were in the original contract.
4. That this addendum shall be read together with the original contract for the Supply, Installation, Testing, Commissioning Training and Maintenance of Radiology Equipment (CT Scan) for Singida Regional Referral Hospital, Tabora Regional Referral Hospital and Dodoma Regional Referral Hospital and shall be without prejudice to the other parts of the Agreement that shall unless expressly amended herein or otherwise remain valid including but not limited to the duration of the Agreement and form part of the original contract.






