BETWEEN

THE BENJAMIN MKAPA HOSPITAL of P.O. BOX 11088, DODOMA a medical care provider established under GN. NO. 453 of 2015 (hereinafter referred to as "the Client") and whose address for the purpose hereof of P.O. Box, 11088, Dodoma (which expression shall include wherever applicable, its legal representatives, agents and assigns) of the one Party.

AND

M/S KAS MEDICS LIMITED, P.O BOX 7856, DAR ES SALAAM, a limited liability Company incorporated in Tanzania under the Companies Act, and having its registered office at Plot No. 11, Vingunguti Industrial Area, **P.O BOX 7856, DAR ES SALAAM** (Hereinafter referred to as "**The Supplier**" which expression shall where the context so permit include its assignees and successors of title) of the one part.

WHEREAS, The Parties hereto are Parties to a **Contract for the Supply, Installation, Testing, Commissioning, Training of ICU, EMD and Laboratory Equipment for Benjamin Mkapa Hospital, Mirembe Hospital and Dodoma Referral Hospital** made on 22nd day of March, 2022.

WHEREAS, the original contract entered by the parties on 22nd March 2022, had the duration period starting from 23rd March, 2022 ending 30th May, 2022.

AND WHEREAS, The parties under the Contract for the Supply, Installation, Testing, Commissioning Training and Maintenance of ICU, EMD and Laboratory Equipments for Benjamin Mkapa Hospital, Mirembe Hospital and Dodoma Regional Referral Hospital are desirous of reviewing the contract by increasing the value of contract and number of participating entities as provided herein;

NOW THEREFORE the client and the service provider do hereby agree as follows:

1. *Amend the name of the contract from Supply, Installation, Testing, Commissioning, Training Of ICU, EMD and Laboratory Equipment for Benjamin Mkapa Hospital, Mirembe Hospital and Dodoma Regional Referral Hospital to Supply, Installation, Testing, Commissioning, Training of ICU, EMD and Laboratory Equipment for Benjamin Mkapa Hospital, Mirembe Hospital, Dodoma Referral Hospital, Singida Referral Hospital and Tabora Referral Hospital*
2. *Additional of quantities that could not be conceived at the time of original contract to the remeasurements to the tune of **Tanzanian shillings One Hundred Twenty Seven Million Nine Hundred Forty Five Thousand Only (Tshs. 127,945,000.00) VAT Exclusive for Singida Regional Referral Hospital and Tabora Regional Referral Hospital.***
3. *The contract sum has changed after additional cost from the original contract amount of Tanzania Shillings three hundred twenty-two million, seven hundred thirty-eight thousand Only (TZS 322,738,000.00) Vat Inclusive resulting to **Tanzanian Shillings Four Hundred Fifty Million Six Hundred Eighty Three only (TZS 450,683,000.00) VAT Exclusive.***
4. The contract terms and conditions shall remain the same as it were in the original contract.
5. That this addendum shall be read together with the original contract for the Supply, Installation, Testing, Commissioning, Training of ICU, EMD and Laboratory Equipment for Benjamin Mkapa Hospital, Mirembe Hospital, Dodoma Referral Hospital, Singida Referral Hospital and Tabora Referral Hospital and shall be without prejudice to the other parts of the Agreement that shall unless expressly amended herein or otherwise remain valid including but not limited to the duration of the Agreement and form part of the original contract.
