1.0 BACKGROUND INFORMATION

- 1.1 The Government of the United Republic of Tanzania has set aside funds for the operations of Iringa Regional Referral Hospital (IRRH) for the financial year 2021/2022. It is intended that part of the fund proceeds will be used to cover eligible payment for the Supply of telemedicine equipment's.

2.0 INVITATION AND OPENING OF THE MINI COMPETITION QUOTATION FORM

On 10th February, 2022 IRRH invited forty bidders through TANePS with specific contract from Government Procurement Services Agency (GSPA) to participate in the tender for the Supply Materials for LAN telemedicine room with quotation No. **AE/005/2021-2022/IRINGA/FA/G/02**

- 2.2 A brief description of the Materials to be procured in each tender are attached through procurement procedural form no. 2 as **Appendix 1**.
- 2.3 The deadline for submission of mini competition quotation form was scheduled on 15th March, 2022 at 11:00 am. Only Six bidders MPULULU ENTERPRISES, ERIBA GENERAL ENTERPRISES, TWINOME GENERAL INVESTMENT, JAMSON COMPUTER SERVICES AND STATIONERY, SISA SOLUTION and CHESAM SOLUTIONS submitted the priced offered with the amount of TZS 2,445,001/= , 2,944,000.01/= , 2,078,750.00/= , 2,410,740.00/=, 3,255,800.00/=, AND 2,295,001.00/= for the Supply Materials for LAN Telemedicine room. The quotation was opened on Tuesday 11.00am at IRRH
- 2.4 The submitted document was opened online through TANePS. The Online tender opening report for read out prices is as shown as **Appendix 2**
