This Addendum is made on this 4th day of July 2022

Between

**MBEYA ZONAL REFERRAL HOSPITAL** of P.O. Box 419, MBEYA (hereinafter referred to as the "**Employer**")

And

**Computech-ICS (T) Limited**, a corporation incorporated under the laws of Tanzania and having its principal place of business at P.O.BOX 5171 Dar Es Salaam (hereinafter called "the Supplier").

Both the Employer and the the Supplier may hereinafter be collectively referred as the "**Parties**" and individually as "**Party**".

**WHEREAS;**

- A. The Parties executed a Contract **FOR SUPPLY INSTALLATION, TESTING COMMISSIONING AND TRAINING OF MEDICAL EQUIPMENT (CT-SCAN 64 SLICES)** on 21<sup>st</sup> March, 2022 (herein referred to as the "**Contract**") at a consideration contract price of Tanzanian Shillings **9,118,799,394** (VAT Exclusive for CT SCAN Machine and VAT Inclusive for Constuction,renovation and extension of Radiology building (hereinafter referred to as the "**Contract Price**")
- B. The Client has realised that On the course of contract implementation to improvements of infrastructure which resulted into construction cost increase of amounting TZS **925,029,600.40** VAT Inxclusive in which the supplier will sub-contract to the qualified contractor.
- C. The Parties are now desirous of amending the terms of the Contract by way of this addendum (hereinafter called the "**Addendum number 1**") to facilitate execution each Party's responsibilities as per additional scope works.

**NOW THEREFORE THE PARTIES DO HEREBY AGREE** as follows:

1. In consideration of the continued observance of the promises and covenants in the Contract as well as any further promises and covenants in this Addendum, it is hereby agreed between the parties with effect on and from the date of this Addendum that the Contract shall be varied as follows;
  - 1.1 By adding the following documents in Clause 1.1 under the Form of Agreement immediately after item "g" and renumbering the succeeding item accordingly as well as any cross referencing affected as aresult of such renumbering;
    - "h. **Bill of quantities from the supplier**"
    - "i. **Drawings**"

1.2 By deletion in Clause 2.1 under the Form of Agreement of the figures "**9,118,799,394**" and substitution thereof of words and figures "ten billion forty-four million two hundred four thousand two hundred thirty-four and four cents (**TZS. 10,043,828,994.40**)"

**The cost is arabottated as follows**

The contract price for Njombe RRH includes Tsh 1,446,939,999.00 for CT SCAN machine plus Tsh 271,079,500.20 for construction of Radiology Building. Total cost for Njombe RRH is Tsh 1,718,019,499.20

III. MBEYA RRH

The contract price for Mbeya RRH includes Tsh 1,446,939,999.00 for CT SCAN machine plus Tsh 271,079,500.20 for construction of Radiology Building. Total cost for Mbeya RRH is Tsh 1,718,019,499.20

IV. SONGEA RRH

The contract price for Songea RRH includes Tsh 1,446,939,999.00 for CT SCAN machine plus Tsh 271,079,500.20 for construction of Radiology Building. Total cost for Songea RRH is Tsh 1,718,019,499.20

V. SUMBAWANGA RRH

The contract price for Sumbawanga RRH includes Tsh 1,446,939,999.00 for CT SCAN machine plus Tsh 205,011,099.60 for renovation and extension of Radiology Building. Total cost for Sumbawanga RRH is Tsh 1,651,951,098.60

VI. SONGWE RRH

The contract price for Songwe RRH is Tsh 1,519,799,899.00 which includes 1,446,939,999.00 for CT-SCAN and 72,859,900.00. for renovation CT SCAN room.



2. This Addendum together with its annexures is hereby attached to and made part of the Contract.
3. Save as therein expressly stated, the Contract shall continue in full force and effect and without amendment waiver or substitution of any provision thereof. Any words in the Contract shall be construed and read as varied and amended by this Addendum and any words or expressions defined in the Contract, unless otherwise defined herein, shall bear the same meaning in this Addendum.
