FORM OF CONTRACT

Between

The Rural Water Supply and Sanitation Agency (RUWASA), having its physical address at Fire Street, P.O. Box 730, **TABORA**, Tanzania (hereinafter called **"The Employer"**) of the one part;

And

ELEGANCE DEVELOPERS CO.LTD having its principal place of business at P. O. Box 35994, Dar Es Salaam, (hereinafter called "the Contractor") of the other part. Both the Employer and the Contractor shall collectively and jointly be known as "Parties".

WHEREAS:

- (a) The Employer is a Government Agency established under the Water Supply and Sanitation Act No. 5 of 2019 which is responsible for development and sustainable management of rural water supply and sanitation projects and the provision of water supply and sanitation services in rural areas;
- (b) The Contactor is a Class four local Company registered under the Laws of Tanzania which is responsible for Civil Works;
- (c) The Employer invited Tenders for Construction of Mambali Kikonoka Water Projects, Extension of Lake Victoria water Supply scheme to Mabisilo and Kipugala villages in Nzega District and Construction of Mbiti - Kakola water supply projects in Uyui District, Tender No. AE – 102/2021-2022/TBR/W/29 under the terms and conditions set forth in this Contract; and
- (d) The Contractor having represented to The Employer that it has the required professional skills, expertise and technical resources, The Employer through the Letter of Notification of Award of Tender with Ref. No. BA.16/145/01/30 dated 24th December,2021 awarded a Tender to the Contractor at the contract sum of Tanzanian Shillings: Nine hundred and eighty million, five hundred seventy six thousand three hundred seventy one Shilling and cent eighty six only (980,576,371.86) VAT Exclusive. (Hereinafter referred to as "the Contract Price"). The work to be completed within One Hundred Eighty (180) days (hereinafter called "Contract Period").

NOW THEREFORE the Parties hereby agree as follows:

- 1. In this contract, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents shall be deemed to form and be read and construed as an integral part to this contract, and shall be taken as complementary and mutually explanatory of one another but in the event of ambiguities, inconsistency or discrepancies within the Contract, the documents shall take precedence/prevail in the order set out below:
 - (a) Form of Contract;
 - (b) Special Conditions of Contract;
 - (c) General Conditions of Contract;
 - (d) Notification of Award of Tender;
 - (e) Letter of Acceptance;
 - (f) Price Schedule (BOQ);
 - (g) Anti bribery Memorandum;
 - (h) Technical Specifications;
 - (i) Drawings; and,
 - (j) APPENDICES
 - (i.) Forms of Securities;
 - (ii.) Registered Power of Attorney; And
 - (iii.) Minutes of Negotiation Meeting.
- 3. In consideration of the payments to be made by The Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with The Employer to execute the proposed Construction of Mambali Kikonoka Water Projects, Extension of Lake Victoria water Supply scheme to Mabisilo and Kipugala villages in Nzega District and Construction of Mbiti Kakola water supply projects in Uyui District (hereinafter called "the Works") and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 4. The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the works, the sum of Tanzanian Shillings: Nine hundred and eighty million, five hundred seventy six thousand three hundred seventy one Shilling and cent eighty six only (980,576,371.86) VAT Exclusive, at the times and in the manner prescribed in this Contract.

- 5. The Employer hereby covenants to pay the Contractor in consideration of the exec and completion of the Works and the remedying of defects wherein the Contract Pri follows:
 - a) 15% Advance Payment; and shall be paid to the contractor not later that Days after submission of a claim supported by an acceptable I Guarantee of the same amount;
 - b) The rest of the payments shall be made upon submission and Acceptance Certificate and it shall be paid to the Contractor within twenty-eight (28) after the date of the acceptance certificate by The Employer
- 6. The Contract price shall be paid in **Tanzanian Shillings** as stipulated under Claus of the SCC.
- The contract shall be executed for the period of one hundred and Eighty (180) of which shall immediately commence from the date of site handling.
