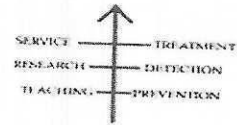

Form of Contract

THIS CONTRACT is made the.....FRIDAY, 24.....day of December, 2021; between **OCEAN ROAD CANCER INSTITUTE (ORCI)**; a corporation incorporated under the laws of the United Republic of Tanzania and having its principal place of business at junction of Barack Obama road/Luthuli road P.O Box 3592 Dar es Salaam, Tanzania (hereinafter called "the Employer"), and **PACIFIC DIAGNOSTICS LTD**, a corporation incorporated under the laws of the United Republic of Tanzania and having its principal place of Plot 46-48, Mikocheni Industrial Area, P.O.BOX 34056 Dar es Salaam, Tanzania (hereinafter called "the supplier").

WHEREAS the Employer desires to engage the Supplier for the **SUPPLY, INSTALLATION, TESTING AND COMMISSIONING OF CT SCAN AT MTWARA ZONAL HOSPITAL** and the Supplier has agreed to such engagement upon and subject to the terms and conditions hereinafter appearing.

NOW IT IS HEREBY AGREED as follows:

1.2 Order of Precedence (Reference GCC Clause 2)
In the event of any ambiguity or conflict between the Contract Documents listed above, the order of precedence shall be the order in which the Contract Documents are listed in Article 1.1 (Contract Documents) above.

1.3 Definitions (Reference GCC Clause 1)
Capitalized words and phrases used herein shall have the same meanings as are ascribed to them in the General Conditions of Contract.

2.1 Contract Price (Reference GCC Clause 12)
The Employer hereby agrees to pay to the Supplier the Contract Price in consideration of the performance by the Supplier of its obligations hereunder. The Contract Price shall be the aggregate as specified in Price Schedule equivalent to **TZS 2,155,673,088.00 (Tanzania Shillings Two Billion One Hundred Fifty-Five Million Six Seventy Three Thousand Eighty Eight Only)**, or such other sums as may be determined in accordance with the terms and conditions of the Contract.

2.2 Terms of Payment (Reference GCC Clause 13)
The terms and procedures of payment according to which the Employer will reimburse the Supplier are given in the corresponding Appendix (Terms and Procedures of Payment) hereto.

The Beneficiary of the project and PE (Mtwara Zonal Hospital) shall instruct its bank to issue an irrevocable confirmed documentary credit made available to the Supplier in a bank in the country of the Supplier. The credit shall be for an amount **TZS 2,155,673,088.00 (Tanzania Shillings Two Billion One Hundred Fifty-Five Million Six Seventy-Three Thousand Eighty Eight Only)**

In the event that the amount payable under Schedule No. 1 is adjusted in accordance with GCC 12.2 or with any of the other terms of the Contract, the Employer shall arrange for the documentary credit to be amended accordingly.

The price given above are firm and final till the completion of the contract this supply, delivery (DDP), installation, testing and commissioning of CT SCAN machines 100% payable against irrevocable, confirmed L/C payable as follows: -

- i) 20% Advance payment against acceptable Advance Payment Guarantee (bank Guarantee or insurance bond)



- ii) 75% by Irrevocable, Transferable and Confirmed Letter of Credit against Shipping Documents. Trans-shipment and Part shipments allowed.
- iii) 5% on completion of installation, testing, training and commissioning of CT SCAN machines and issuance of completion certificate and operational acceptance certificate issued by TANZANIA ATOMIC ENERGY COMMISSION (TAEC) but no later than 180 days from shipment date without any further presentation of documents.
- iv) The projected amounts for the warrant period have been included in the gross cost payable in periodical installments. There will be no separate contract which will include successive years warranty.

- 3.2 Reference in the Contract to any Appendix shall mean the Appendixes attached hereto, and the Contract shall be read and construed accordingly.

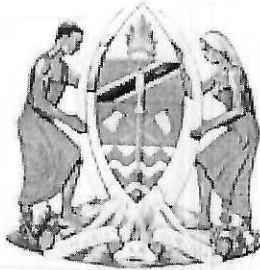

21.3 In the event that the period of suspension under above GCC 13.1 actually exceeds one hundred eighty (180) days, the Employer and Contractor shall mutually agree to any additional compensation payable to the Contractor.

21.4 When the Contractor is notified by the Project Manager that the plant is ready for Pre-commissioning, the Contractor shall proceed without delay in performing all the specified activities and obligations under the contract.

[The above SCC 14 may be used when performance of Pre-commissioning activities and/or Functional Guarantees will be tied to the completion of other facilities which are not under the responsibilities of the Contractor (e.g., completion of transmission lines to connect to the grid a power plant constructed under the Contract).]



"Adjudicator" means the person or persons appointed by the Appointing Authority named in the SCC to make a decision on or to settle any dispute or differences between the Employer and the Contractor referred to him or her by the parties pursuant to GCC 6.1 (Adjudicator) hereof.

"Contract Price" means the sum specified in Article 2.1 (Contract Price) of the Agreement, subject to such additions and adjustments thereto or deductions therefrom, as may be made pursuant to the Contract.

"Facilities" means the Goods to be supplied and installed, as well as all the Installation Services to be carried out by the Contractor under the Contract.

"Force Majeure" shall mean any event beyond the reasonable control of the Employer or of the Contractor, as the case may be, and which is unavoidable notwithstanding the reasonable care of the party affected.

"Goods" means permanent plant, equipment, machinery, apparatus, articles and things of all kinds to be provided and incorporated in the Facilities by the Contractor under the Contract (including the spare parts to be supplied by the Contractor under GCC 7.3 hereof), but does not include Contractor's Equipment.

"Installation Services" means all those services ancillary to the supply of the Goods for the Facilities, to be provided by the Contractor under the Contract; e.g., transportation and provision of marine or other similar insurance, inspection, expediting, site preparation works (including the provision and use of Contractor's Equipment and the supply of all construction materials required), installation, testing, pre-commissioning, commissioning, operations, maintenance, the provision of operations and maintenance manuals, training, etc.

"Contractor's Equipment" means all plant, facilities, equipment, machinery, tools, apparatus, appliances or things of every kind required in or for installation, completion and maintenance of Facilities that are to be provided by the Contractor, but does not include

1. Opening of the meeting:

The quoted price for the supply of CT Scan were read out at the meeting to be 1,865,040,000.01 against the budget of TZS 2,180,000,000, The need for negotiation between ORCI and PACIFIC was because of the omitted items for trainings and Workstations from Mtwara Zonal specifications which needed to be resolved at the meeting and also to probe for the cost reduction.

The chairman required the clarification of the slice between 64 and 128, queried to know which one Pacific Diagnostic supply will, Pacific responded by saying that they will supply a 128 slice CT Scan machine at no additional cost complying to the Mtwara Specs of at least 64 slices.

With regards to monetary discount, Pacific representative agreed to give a discount of the total cost of 899,000 USD from the original submitted bid price of **USD 1,033,100.**

With the Budget of TZS **2,180,000,000**, the total costs for supplying CT Scan machine with 128 slice was agreed by the Pacific Director to be **899,000 USD** using a conversion rate of 2330 it become **TZS 2,094,670,000/=** saving TZS **85,330,000** for Mtwara Zonal Hospital and which can be used in procuring other radiology items for the IMF project hospitals.

The team after thoroughly discussion accepted the recommendation to take the CT SCAN with 128 Slice coming with all the accessories at an agreed quoted price



of **899,000 USD** plus the additional cost that will come with trainings and workstations.


