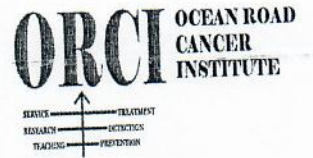

This ADDENDUM TO THE PRINCIPAL AGREEMENT is made this.11 day of. MAY 2022

BETWEEN

OCEAN ROAD CANCER INSTITUTE (ORCI); a corporation incorporated under the laws of the United Republic of Tanzania and having its principal place of business at junction of Barack Obama road/Luthuli road P.O Box 3592 Dar es Salaam, Tanzania (hereinafter called "the Employer"),

AND

ANUDHA LIMITED, a corporation incorporated under the laws of the United Republic of Tanzania and having its principal place of Plot 2169/82& 8170/82, Morogoro Road, Opp. DART Kisutu Bus stand, Dar es Salaam, Tanzania (hereinafter called "the supplier").

M/S ANUDHA LIMITED, P.O.BOX 5982, DAR ES SALAAM (Here in after referred to as "The Supplier/Tenderer") which expresslon shall, where the context so admits, include assigns and successors in title of the other part.

WHEREAS, parties to this Addendum hereby mutually agree that this an addendum to the agreement for the **SUPPLY OF LABORATORY EQUIPMENT FOR MTWARA ZONAL HOSPITAL AND MTWARA RHH** and signed by both parties on the 11 day of **MAY 2022** (Herein referred to as the Principal Agreement) and shall be read together with this Addendum,

AND WHEREAS, Pursuant to the Provisions of Article 2. Contract Price and Terms of Payment of the Purchase Agreement, the parties wish to amend the Purchase Agreement as follows;

#### CLAUSE 4

##### AMMENDMENT OF CLAUSE 4 OF THE PRINCIPAL AGREEMENT

- 1.1. The contract price named in clause 4 of contract agreement reference to GCC clause 16 of the principle contract agreement is hereby amended by adding 20,000,000/= to the unit price of **SUPPLYING BLOOD GAS ANALYZER MACHINE FOR MOROGORO RRH**. Thus, the contract price shall be TZS 123,485,000.00 (One Hundred and Twenty Three Million, Four Hundred Eighty Five Thousand Only.),
- 1.2. The schedule of requirements which was part of the principal agreement is herebyamended by adding the unit of supplying Blood Gas Analyzer machine by 1pc, thus the

unit price of Blood Gas Analyzer machine shall be 40,000,000 after additional of (One)1 pc from 20,000,000/=

- 1.3. The reduction costs of the named items shall become operational with effect from this 11 day of MAY 2022.

CLAUSE 2

EXCEPTIONS

- 2.1. Save for the above amendments the rest of the provisions of the Principal Agreement shall remain unaltered.

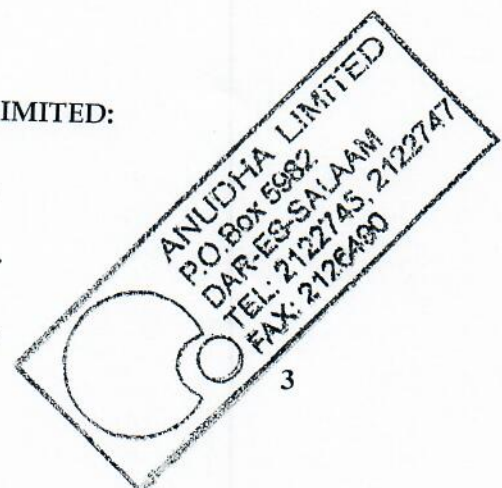
