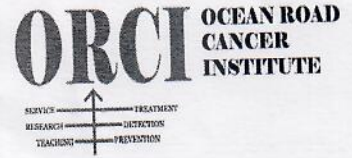

This ADDENDUM TO THE PRINCIPAL AGREEMENT is made on this 10th day of June, 2022.

BETWEEN

OCEAN ROAD CANCER INSTITUTE (ORCI); a corporation incorporated under the laws of the United Republic of Tanzania and having its principal place of business at the junction of Barack Obama Road / Luthuli Road, P.O. Box 3592 Dar es Salaam, Tanzania (hereinafter called "the Employer"),

AND

PACIFIC DIAGNOSTICS LIMITED, a corporation incorporated under the laws of the United Republic of Tanzania and having its principal place of business at Plot 46-48, Mikocheni Industrial Area, P.O. Box 34056, Dar es Salaam, Tanzania, (hereinafter referred to as "The Supplier/Tenderer"), which expression shall, where the context so admits, include assigns and successors in title of the other part.

WHEREAS parties to this addendum hereby mutually agree that this is an addendum to the PRINCIPAL agreement for the SUPPLY OF MRI 1.5 TELSAs FOR ORCI AND MTWARA ZONAL HOSPITAL and signed by both parties on the, 2022 (Herein referred as the Principal Agreement) and shall be read together with this Addendum,

And WHEREAS, pursuant to the Provisions of Article 2. Contract Price and Terms of payment of the purchase Agreement, the parties wish to amend the purchase agreement as follows;

CLAUSE 1

AMMENDMENT OF CLAUSE 2 (2.1) OF THE PRINCIPAL AGREEMENT

The contract price named in reference to clause 2.1 of the principal agreement as reference to GCC clause 12 of the principal contract agreement, is hereby amended by adding TZS 2,600,000,000 /= VAT Inclusive, The added cost breakdown are TZS 2,438,208,000 /= for cost for the Supply of MRI 1.5 TESLA FOR MUHIMBILI ORTHOPAEDIC UNIT (MOI),

at MOI Dar es Salaam and the remaining TZS 161,792,000/= are initial estimation for the renovation cost for the MRI building at MOI, to the contract price of SUPPLY OF MRI 1.5 TELSAs FOR ORCI AND MTWARA ZONAL HOSPITAL. Thus, the contract price shall be **TZS 8,081,088,000/= (Eight Billion Eighty one million Eighty Eight thousand)**

- 1.1 The schedule of the requirements which was part of the principal agreement is hereby amended by adding 1pc of MRI machine by **TZS 2,438,208,000/=**, Thus total of 3 pc of MRI will be supplied.
- 1.2 The schedule of requirements which was part of the principal agreement is hereby amended by adding renovation work of MRI building to Pacific Diagnostic at estimated cost of **TZS 161,792,000/=**.
- 1.3 The added costs of the Supplying MRI and renovation cost shall become operational with effects from this **10th Day of June, 2022**.

CLAUSE 13

AMMENDMENT OF CLAUSE 13 (14.3) OF THE PRINCIPAL AGREEMENT

The contract performance security named in reference to clause 13 of the principal agreement as reference to GCC clause 14 of the principal contract agreement, is hereby amended by stating that "The performance security shall be in the form of bank guarantee only.

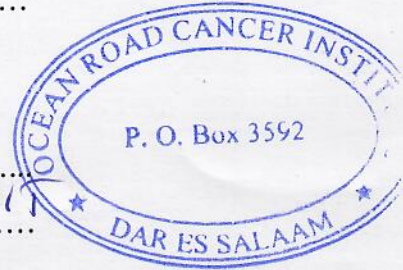
CLAUSE 2 EXCEPTIONS
