This **ADDENDUM TO THE PRINCIPAL AGREEMENT** is made this 25 day of 03 2022

BETWEEN

BUGANDO MEDICAL CENTRE (BMC), P.O. BOX 1370, MWANZA, and a Public Private Institution operating under the Partnership of the Government of the United Republic of Tanzania and the Tanzania Episcopal Conference (TEC) (hereinafter referred to as “**the Employer/ the Buyer or BMC**”) which expression shall, where the context so admits, include assigns and successors in title of the one part;

AND

M/S PACIFIC DIAGNOSTICS LIMITED, P.O.BOX 34056, DAR ES SALAAM (Here in after referred to as “**The Supplier/Tenderer**”) which expression shall, where the context so admits, include assigns and successors in title of the other part.

WHEREAS, parties to this Addendum hereby mutually agree that this an addendum to the agreement for the **supplying, installation, testing, commissioning, training and maintenance of lot 1: four (4) 64 slice CT scan machine, lot 2: One (1) 128 slice CT scan machine** and signed by both parties on the 25 day of 03 2022 (Herein referred to as the Principal Agreement) and shall be read together with this Addendum;

AND WHEREAS, Pursuant to the Provisions of **Article 2. Contract Price and Terms of Payment** of the Purchase Agreement, the parties wish to amend the Purchase Agreement as follows;

ARTICLE 1

AMMENDMENT OF ARTICLE 2 (2.1) OF THE PRINCIPAL AGREEMENT

- 1.1. The Contract Price named in article 2 (2.1) reference to GCC clause 11 of the principle contract agreement is hereby amended by reducing **40,000,000/=** to the unit price of the CT scan both of them (64 CT scanner machine and 128 CT- SCAN MACHINE). Thus, the Contract Price shall be **9,300,000,000/= (NINE BILLION THREE HUNDRED MILLION TANZANIAN SHILLINGS)** as the aggregate of **7,240,000,000/= (SEVEN BILLION TWO HUNDRED FOURTY MILLION TANZANIAN SHILLINGS)** for **four (4) 64 slice CT Scan machine** and **2,060,000,000/= (TWO BILLION AND SIXTY MILLIONS TANZANIAN SHILLINGS)** for **(1), 128 slice CT-SCAN MACHINE**.
- 1.2. The schedule of requirements which was part of the principal agreement is hereby amended by reducing the unit price of each CT SCAN machine by **40,000,000/=**, thus the

unit price of 64 SLICE CT SCAN MACHINE shall be 1,810,000,000/= after deduction of 40,000,000/= from 1,850,000,000/= and for 128 CT- SCAN unit price shall be 2,060,000,000/= after deduction of 40,000,000/= from 2,100,000,000.

- 1.3. The reduction costs of the named items shall become operational with effect from this 25th day of 09th 2022.

ARTICLE 2

EXCEPTIONS

- 2.1. Save for the above amendments the rest of the provisions of the Principal Agreement shall remain unaltered.
