PURCHASE AGREEMENT

THIS PURCHASE AGREEMENT is made the Aday of 61, 20 22

NOW, THEREFORE, THE PARTIES here to agree and declare as follows:

Article 1. Contract Documents 1.1 <u>Contract Documents</u> (Reference GCC Clause 2) The following documents shall constitute the Contract between the Employer and the Supplier, and each shall be read and construed as an integral part of the Contract:

- (a) This Contract Agreement and the Appendixes hereto
- (b) Tender and Price Schedules submitted by the Supplier
- (c) Special Conditions of Contract
- (d) General Conditions of Contract
- (e) Technical Specifications and Drawings
- (f) Procedures (as listed)
- (g) Acceptance letter
- (h) Negotiation report

1.2 Order of Precedence (Reference GCC Clause 2)

In the event of any ambiguity or conflict between the Contract Documents listed above, the order of precedence shall be the order in which the Contract Documents are listed in Article 1.1 (Contract Documents) above.

1.3 Definitions (Reference GCC Clause 1)

Capitalized words and phrases used herein shall have the same meanings as are ascribed to them in the General Conditions of Contract.

2.1 Contract Price (Reference GCC Clause 11)

The Employer hereby agrees to pay to the Supplier the Contract Price in consideration of the performance by the supplier of its obligations hereunder. The Contract Price shall be the aggregate of TZS **613,27,8500 (SIX HUNDRED THIRTEEN MILLION TWO HUNDRED SEVENTY-EIGHT THOUSAND FIVE HUNDRED)** Such other sums as may be determined in accordance with the terms and conditions of the Contract.

2.2 <u>Terms of Payment</u> (Reference GCC Clause 12)

The terms and procedures of payment according to which the Employer will reimburse the Supplier are given in the corresponding Appendix (Terms and Procedures of Payment) hereto.

The supplier shall be paid an advance payment of 60% after full delivery of the items mentioned, 40% after full installation, testing, commission, inspection and training.

Article 3. Effective Date for 3.1 Determining Fime for Completion

Effective Date (Reference GCC Clause 1)

The Time of Completion of the Facilities shall be determined from the date when all of the following conditions have been fulfilled:

Article 2. Contract Price nd Terms of Payment.

- (a) This Contract Agreement has been duly executed for and on behalf of the Employer and the Supplier;
- (b) The Supplier has submitted to the Employer the performance security and the advance payment guarantee;
- (c) The Employer has paid the Supplier the advance payment.

Each party shall use its best efforts to fulfill the above conditions for which it is responsible as soon as practicable.

3.2 If the conditions listed under 3.1 are not fulfilled within two (2) months from the date of this Contract notification because of reasons not attributable to the Supplier, the parties shall discuss and agree on an equitable adjustment to the Contract Price and the Time for Completion and/or other relevant conditions of the Contract.

- 4.1 The Appendixes listed in the attached List of Appendixes shall be deemed to form an integral part of this Contract Agreement.
- 4.2 Reference in the Contract to any Appendix shall mean the Appendixes attached hereto, and the Contract shall be read and construed accordingly.
